RELEASE AND WAIVER: I understand that bicycling requires physical conditioning and I represent that I am in sound medical condition capable of participating in this ride without risk to myself or others. I have no known medical impediment which would endanger myself or others. I agree that I will be solely responsible for the condition and adequacy of my bicycle, safety gear, and riding equipment. I will ride safely and within the limits of my own abilities, my equipment and the riding conditions and in a manner so as not to endanger myself or others. I agree to abide by all rules and regulations of the Circus City Cyclists Bicycle Club. I understand that bicycle riding is a potentially hazardous activity and I voluntarily participate in it of my own free will and choice. In choosing to attend and participate in this ride, I fully accept and assume all risks whether before, during, or after the ride. Acknowledging that such risks exist, I HEREBY RELEASE, WAIVE, DISCHARGE, COVENANT NOT TO SUE AND AGREE TO HOLD HARMLESS THE CIRCUS CITY CYCLISTS BICYCLE CLUB, ITS OFFICERS, MEMBERS, VOLUNTEERS, SPONSORS, PARTICIPATING CLUBS, COMMUNITIES AND ORGANIZATIONS, AND SUPPORT PERSONNEL (collectively, "Releases") from any and all claims or liability for personal injury or property damage I may suffer directly or indirectly arising out of or relating in any respect to my attending or participating in this ride. This waiver and release of all claims, demands, actions and liability shall include, without limitation, any injury, damage of loss to my person or property which may be (a) caused by any act, or failure to act, by Releases even if said injury, damage, or loss results from the negligence of any or all of the above-identified Releases or (b) sustained by me before, during, or after the ride. I agree to indemnify and hold harmless Releases for all lawsuits, losses, damages, claims, and expenses, including attorneys fees and costs arising from or related in any respect to my participation in this ride or my breach of this agreement. This provision will apply regardless of whether or not the lawsuit, losses, damages, claims, expenses, attorneys fees and/or costs arises out of the negligence of any of the Releases. If I am a minor, my parent or guardian is signing on my behalf and we both agree to be bound by the terms of this agreement. The laws of the State of Indiana will govern any disputes or other matters relating to this Consent and Liability Release. THIS AGREEMENT MAY NOT BE MODIFIED ORALLY AND MAY NOT BE WAIVED IN ANY RESPECT. I HAVE READ THIS AGREEMENT, WAIVER AND RELEASE AND AGREE TO ACCEPT ITS TERMS.
